SUMMARY

Jerry Anthony is an Associate Professor at the School of Planning and Public Affairs, University of Iowa.

Anthony is an accomplished scholar. His article, “The effect of Florida’s Growth Management Act on housing affordability,” was named one of the most outstanding articles published in the *Journal of the American Planning Association* in 20 years. He was named a HUD Urban Scholar in 2001. Anthony explores U.S. and international issues in his research. One of his current research projects examines housing and community development factors that correlate with STD morbidity in Iowa.

Anthony is an outstanding teacher. He has received the “Excellence in Planning Education” award from the Iowa chapter of the American Planning Association—one of only two educators in Iowa to be ever given this award. Anthony has taught students from over 90 universities in Asia, Australia, Europe, Africa, and North and South America in in-person classes. Since 2009, he has taught a study abroad course titled “Sustainable Development: The Kerala experience” in the University of Iowa’s internationally renowned IndiaWinterim program. This course taught in Kerala, India attracts students from many U.S. colleges, such as Columbia University, the University of California at Berkeley, and the University of North Carolina at Chapel Hill.

Anthony’s efforts have significant societal impact. In 2003, Anthony co-founded a non-profit entity, [Housing Trust Fund of Johnson County](#), to provide a new and flexible source of finance for affordable housing development in Johnson County, Iowa. From 2004 onwards, this entity has disbursed over \$12 million to help create hundreds of reasonably-priced housing units.

In 2019, Anthony was awarded the University of Iowa’s prestigious [Michael J. Brody award for Excellence in Service](#). In 2020, Anthony was named a [Fellow of the American Institute of Certified Planners](#), the highest recognition for Urban Planners in the U.S., and is the only person so honored in the state of Iowa in 20 years.

HTFJC provides a new and flexible source of finance for affordable housing development in Johnson County, Iowa. Co-authored the first Strategic Business Plan for this organization, a successful \$238,000 grant application that provided start-up funds, and the first Distribution Plan to guide disbursement of funds received. HTFJC is now managed by a volunteer Board, a salaried Executive Director and additional staff. Since 2004, HTFJC has disbursed over \$12 million and helped create over 900 affordable housing units in Johnson County, Iowa.
